Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, and SEBI Circular No. SEBI/HO/CFD/PoD-2/CIR/P/0155 dated November 11, 2024, we inform you that consequent to Hon'ble Supreme Court's Order dated 23<sup>rd</sup> October 2024 vide which it has upheld the State's authority to levy import/export fees on denatured alcohol, the Excise Commissioner of Uttar Pradesh has reinstated import/export fees on denatured alcohol by revoking its earlier Order of 2018 which had suspended import/export fees on denatured alcohol. The said Order has been brought to the notice of undersigned today, i.e., 11<sup>th</sup> July 2025 at around 5.26 pm. Details of the matter required under SEBI Circular are:
