**Sub. : Update on expansion of Chlor-Alkali Facility and Power Plant at Bharuch (Gujarat) under Regulation 30 (6) of SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015**

Dear Sir/Madam,

Pursuant to our letter dated June 14, 2016 submitted with the Stock Exchange(s) on the subject mentioned above, we had received an e-mail from National Stock Exchange of India Ltd. on June 16, 2016 regarding further clarifications. In this regard, we wish to draw your attention to our letters dated October 4, 2014 and November 2, 2015 (copies attached as Annexure -1 and 2 respectively for ready reference) wherein we had advised the details about the Chlor-Alkali and Power Plant expansion project.

Notwithstanding above, we are giving the details to your queries as below:

**1. Existing capacity:**

\* This power is for entire Kota complex that houses Fertilizers, Chlor-Alkali, Plastics, Cement, PVC Compounding and Fenesta Manufacturing business

**2. Existing capacity utilization** – The plants are running at full capacity except routine maintenance shutdown.

**3. Proposed capacity addition:**

Power Capacity	-	55 - 60 MW	55 -60 MW

\*\*Out of this 499TPD, the company has already commissioned 420 TPD on 14<sup>th</sup> June, 2016.

**4. Period within which the proposed capacity is to be added** – The entire expansion project will be completed by September / October, 2016

**5. Investment required** – Rs. 607.20 Crores (534 Cr + 59.1Cr +14.1 Cr.)
